When will solar panels be approved in Spain?

But this funding ended on December 31st 2023. The Spanish government has requested for funding to continue until 2026. However, at the time of writing this there is no confirmation of further solar panel subsidies in Spain. They may be approved in the coming months.

The Real Decreto 477/2021 published June 2021 announced EUR1.3 billion in funding for homes and businesses to install solar panels, solar batteries and aerothermal units in Spain.
